Festival Vendor Check In

- ❖ Check in is in the NW Section of Craig Ranch Park near the Amphitheater
- ❖ Check in be open 7:00am – 11:00am
- ❖ **You may drive on BUT MUST REMOVE YOUR VEHICLE BY 11AM**
- ❖ During the event, the MAIN EXIT will function as Vendor Entrance
- ❖ Familiarize yourself with the TAX FORM to submit at check out



Festival Vendor Wristbands

- ❖ Your space comes with 2x wristbands
- ❖ You may have purchased more already
- ❖ You can purchase more in the vendor portal
- ❖ You may bring additionally purchased wristbands to the MAIN EXIT of the Festival during the event to hand entry to others joining for their shift
- ❖ Additional entries are \$10 - GA entry is \$30 at the gates



Taxes - ALL VENDORS

❖ EVERY VENDOR

- ❖ Receives a sales tax form in triplicate
- ❖ Completes and returns a tax form in triplicate (1 for you, 1 for us, 1 for tax dept)
- ❖ If tax is due, include payment with the form in the envelope provided via cash or check (if you sell nothing or are non-taxable then complete anyway with 0)
- ❖ Yes – EVERY VENDOR - this is how Dept of Taxation wants it – please be helpful
- ❖ It is your choice to fill in other info – tax dept gets your info and will be following up
- ❖ YES - YOU ALL WILL COMPLETE THIS FORM 😊

Food Vendors

◆ Health Inspection

- ◆ SNHD will coordinate with you in advance
- ◆ At the event, they will inspect at 11am for health and safety
- ◆ BE SURE TO
 - ◆ Know access to potable and wastewater plans
 - ◆ Have your hand washing station ready
 - ◆ Have access to hot water (kettle etc)
 - ◆ KNOW WHERE HAND WASH STATIONS ARE FOR RESTROOM AREAS
 - ◆ Know temps and food safety parameters / timelines
 - ◆ Have an ice scoop and proper utensils

Check OUT

- ◆ Early Check-OUT begins at 7pm (Food vendors and those who chose to stay may remain until the event ends at 11pm)
 - ◆ You may leave your area clean and clear
 - ◆ You MUST CHECK OUT with our vendor team
 - ◆ You MUST TURN IN YOUR TAX FORM
 - ◆ BE SURE TO
 - ◆ Complete your Tax form in TRIPLICATE
 - ◆ Remit any balance due for taxes in your provided envelope
